## CRAFTSERVICE PROVIDERS DRIVER QUALIFICATION POLICY

### APPLICATION FOR DRIVER STATUS

If you are a permittee or member in the IATSE Local 411 Craftservice Providers Caucus and wish to upgrade to “Driver Qualified” status you must complete the following:

- Successfully complete the IATSE Local 411 Craft Truck Driving Trade Test and MTO Regulation Seminar.
- Pay the Craft Truck Driving Trade Test Fee of \$100.00 (non-refundable)  
This fee can be paid by cash, debit, credit card (Visa, MasterCard or AMEX - in the office, not over the phone), money order or certified cheque. You can also pay via PayPal (even if you do not have a PayPal account) by requesting an invoice to be emailed to you. We do not accept personal cheques as a form of payment for Permit applications. NOTE: if paying by cash you must have exact amount.
- Copy of the front and back of your valid full G (or higher) driver's license
- 3-year ‘uncertified’ driver's abstract (dated 30 days or less from date of application)

Upgrade applications can be sent via **Email** to [office@iatse411.ca](mailto:office@iatse411.ca) or can be **dropped off** at the 411 office located at **2087 Dundas Street East, Unit 104, Mississauga, ON L4X 2V7**. The Local 411 office will contact you to schedule your attendance at the IATSE Local 411 Craft Truck Driving Trade Test and MTO Regulation Seminar.

All required application documents must be completed and submitted before attending the IATSE Local 411 Craft Truck Driving Trade Test and MTO Regulation Seminar.

Successful applicants for “Driver Qualified” status will have their status changed and will be added to the Craftservice Driver availability list (members only).

Failure to pass the IATSE Local 411 Craft Truck Driving Trade Test will result in a complete reapplication in order to be tested again. This includes payment of an additional \$100 Trade Test Fee paid in advance.

Any intentional misrepresentation of your experience will result in an automatic decline of your application for Driver status. Any applicants declined on this basis shall not be reconsidered for Driver status for a minimum period of one year.
